Business experience:

I have owned and operated multi-million pound businesses specifically in the recruitment industry since 1968. From 1972 until 2022, I was the CEO of The TRG Group which delivered a range of services over the years to the private and public sectors including outsourcing, managed services, a full-service employment agency and executive search. I am the chairman of Trevor Gilbert & Associates and also the CEO – UK of Cross Border Claims which provides legal assistance and support by way of third-party administration.

My specialist knowledge of real-time employment and recruitment issues is widely recognised.

I was an ad hoc advisor to the John Major Conservative government on disability issues and in my capacity as President of the Institute of Employment Consultants at the time worked closely with the Minister of State, Minister for Disabled People, the Rt. Hon. Alistair Burt. I initiated and formulated the IEC's code of professional conduct in 1991. I was also closely involved in the evolution of the New Deal programmes, focusing on getting people into work rather than training.

I have practised as an independent expert witness employment analyst and career profiler since 1989 and personally delivered evidence in over 2,500 cases, quite often of high value and demanding detailed investigation and analysis. I write reports on personal injury, clinical negligence, for employment tribunals, matrimonial matters and historic child abuse. Although I am highly competent in a range of occupations, my specialist areas are investment banking/financial services, hospitality/catering, performing arts, martial arts and the recruitment agency industry.

I have been involved in landmark and important high-value cases such as:

- Helmot v Simon (2012) on behalf of the Defendant
- McGlone v NHS Greater Glasgow & Clyde Board (2012), in which I was the lead expert for the Defender.
- I was the sole appointed employment expert in the largest claim in British legal history pleaded at £238M (X children v Minister, 2018).
- I was also the sole appointed employment expert in Jhuti v Royal Mail Group. My evidence, upon which the Tribunal wholly relied, resulted in Ms Jhuti being awarded £2.36M (2023).

My instructions are derived from the majority of claimant and defendant personal injury/clinical negligence firms in England and I have delivered evidence and my reports accredited or used in settlement negotiations in many other countries including Scotland, Wales, Northern Ireland, Eire, the Channel Islands, Italy, Gibraltar, South Africa, Germany, Spain, Australia, Hong Kong, and Kosovo.

I have a particular interest in the application of data from the Annual Survey of Hours and Earnings and written extensively on the subject for the Association of Personal Injury Lawyers' magazine 'Focus'. I was able to advise Robin de Wilde QC, then editor of Facts & Figures, that data historically provided by another employment expert practice was incomplete as it referred only to mean values and as a result the full range of data including median values are now included.

I estimate that during the course of my long career I have interviewed around 10,000 people from a wide variety of occupations and at all levels and seen three times as many application forms/CVs.
